1. **Insurance:** We understand that excess medical insurance is provided by **Triple Threat Summer Basketball League**. If an athlete has other medical coverage that coverage will be applied first. If an athlete has no other coverage, the provided policies become primary subject to the terms and condition of each policy. There is a deductible fee, and claims must be submitted within 30 days of an injury or accident. We understand that the **Triple Threat Summer Basketball League** policy applies to Triple Threat authorized events only.
2. **Release:** We recognize the possibility of physical injury associated within the sport of basketball. We release **Triple Threat Summer Basketball League**, and their officers, directors, coaches, employees, agents, volunteers, sponsors, participating athletes, other parents, representatives and successors, and the schools, school districts, religious organizations and other owners of the facilities where games are played and their employees (all of the foregoing are collectively referred to herein as the **Triple Threat Summer Basketball League** “parties”), from any and all liabilities, claims, damages, and expenses, whether known or unknown, sustained by the player or by the undersigned which in any way arise out of, or are connected with or relate to the participation by the player in any activity (including, without limitation, transportation to and from activities) organized by or in any way associated with **Triple Threat Summer Basketball League**.
3. **Indemnity:** We hereby indemnify **Triple Threat Summer Basketball League** parties from and hold each of them harmless against any and all losses, liabilities, claims, damages, and expenses which any of them may suffer or incur arising out of or resulting from the players participation in any activities of **Triple Threat Summer Basketball League** or the breach by the undersigned, by the player or by a member or the family of the undersignees or the player, as the case may be, or the Rules and Regulations of the Agreement.
